Roth VIPANEL® is a high-quality shower wall panels in the special décor. The carrier material consists of a digitally printed aluminum composite material. Currently, there is no harmonized standard for this product to obtain a declaration of conformity.

This European Standard specifies product characteristics for plastic wall protection plates, which are decorative and protective, but not structural.

The requirements covered by this European Standard. Products are to be used as cladding for attachment by means of adhesive on interior walls and wall partitions can be used.

This draft European standard contains for the characteristics of each of these products requirements, evaluation methods (e.g. test, calculation or description) and types of

declaration. It also establishes methods for evaluating and verifying the performance of the products.

Decorative wall coverings - rolls; German version IN 15102:2019.

This document applies to wall coverings in roll form, which are primarily used for decorative purposes on interior walls, partitions or ceilings can be glued on.

Certain however, wallcoverings in roll form can also be minor to sound absorption and heat resistance. The European Union standards for wall coverings in the form of rolls, which are based on refers to this document and in which additional product definitions and requirements provided include the following: - finished paper, vinyl and plastic wall coverings (EN 233), wall coverings for post-treatment (EN 234), -textile wall coverings (EN 266), - cork rolls (IN 13085), - heavy-duty wall coverings (EN 259-1).

In addition, this standard also specifies the assessment and verification of constancy of performance (en: assessment and verification of constance of performance, AVCP) the characteristics and marking of these products.

This document does not apply to:

Wall coverings that are predominantly structurally or structurally serve a protective purpose. This document (EN 15102:2019) has been approved by the technical committee CEN/TC 99 "wallcoverings", the secretariat of AFNOR (France).
